#### **COLLABORATION**

RSEA works with the Louisiana State Employees Retirement System (LASERS) and the Office of Group Benefits (OGB) to provide information to the state Legislature and Louisiana Congressional leaders on retirement and health benefit issues. RSEA is able to engage in lobbying efforts that LASERS, OGB, and state employees, legally cannot due to Civil Service Rules.

#### **ACCOMPLISHMENTS**

- RSEA fought all the way to the Louisiana Supreme Court and defeated establishment of the Cash Balance Retirement Plan for employees, thereby retaining the current defined benefit plan.
- RSEA fought for preservation of the administration of the OGB insurance plan under state control, and helped avoid total privatization of the system.
- RSEA fought to preserve the state income tax exemption for state retirees by lobbying successfully against any changes to the current exemptions.
- 4) RSEA continues to lobby successfully against inclusion of retirement issues in any future calls for a State Constitutional Convention, thereby preserving our benefits in the state constitution.
- RSEA lobbied successfully, along with others, during the 2021 legislative session against an increase in the state minimum retirement age for state employees and teachers to age 67.
- RSEA continues to lobby for a retiree COLA (Permanent Benefit Increase) for all eligible state retirees of LASERS.
- 7) RSEA has fought tirelessly against any and all attempts over the years to establish a defined contribution (DC) retirement system, in lieu of the current defined benefit (DB) plan.
